AGENCY PROFILE

The Philippine Fisheries Development Authority (PFDA) is a government-owned and controlled corporation (GOCC) attached to the Department of Agriculture. It is mandated to promote the development of the country's fishing industry through the provision of post-harvest infrastructure facilities and essential services that improve efficiency in the handling and distribution of fish and fishery products and enhance their quality.

In 1976, the Philippine Fish Marketing Authority (PFMA) was created by virtue of Presidential Decree No. 977 to address and provide solutions to the fishing industry's post-harvest problems. In 1982, the PFMA was renamed as Philippine Fisheries Development Authority through Executive Order 772 (amending PD 977) with increased functions and powers and a revised constitution of the Board of Directors.

At present, the PFDA manages nine regional fish ports (RFP), one municipal fish port (MFP), and four ice plants and cold storage facilities (IPCS) which serve as trading hubs for the post-harvest handling, trading, and distribution of fish and fishery products across the country. With several rehabilitation and modernization projects underway, the PFDA continues to enhance its services by building effective and sustainable post-harvest facilities and infrastructure for the thriving fisheries industry, paving the way for a food-secure and resilient Philippines in the years to come.



isDA ON THE GO Highlights

After more a year from its official launch, isDA ON THE GO, the Philippine Fisheries Development Authority's flagship Corporate Social Responsibility (CSR) Project, has expanded to 55 locations and continues to supply affordable and quality fish and fishery products amid the community guarantine due to COVID-19 pandemic.

The iOTG project has sold more than 86,700 kilos of fish and fishery products, benefiting around 308,000 families. Further, the 55 locations are distributed in four modalities: retailing market; KADIWA partnership; direct sales to groups, institutions, and villages; and market on wheels. Retailing markets are located in 22 Waltermart supermarket outlets in Metro Manila, Bulacan, Tagaytay City, Nueva Ecija, Tarlac, Pampanga and Batangas.

Meanwhile, is DA ON THE GO outlets through KADIWA Partnership, a tie-up program with the Department of Agriculture's marketing program "Kadiwa ni Ani at Kita",

are currently located in 19 various areas in Quezon City, Marikina City, Taquiq City, Navotas City, Pasig City, and Cainta City, Rizal. Private retailers and direct sales are outlets in 14 locations led by private individuals or groups in various institutions and villages like Eco-Friendly Women of NFPC, St. Luke's Hospital, Taguig, Sikatuna Villager, and Don Jose Heights in Quezon City.

Lastly, market on wheels are isDA ON THE GO outlets located at scheduled trade fairs initiated by Local Government Units (LGUs). The project was officially launched last April 8, 2019 in Antipolo City, Rizal as the pilot location. The project offers various fish species including galunggong, tulingan, mackerel, cream dory, salay-salay, squid rings, pampano, mixed seafoods, tuna belly, tuna panga, among others.

ISO 9001:2015 re-certification of PFDA units

The year 2020 ended well for the Philippine Fisheries Development Authority (PFDA) - Quality Management System (QMS) after successfully complying with the requirements of the International Organization for Standardization (ISO) 9001:2015 surveillance audits for Central Office and six of its Regional Fish Ports (RFPs).

The PFDA - Central Office and RFPs namely: Navotas Fish Port Complex (NFPC), Davao Fish Port Complex (DFPC), General Santos Fish Port Complex (GSFPC), Iloilo Fish Port Complex (IFPC), Lucena Fish Port Complex (LFPC), and Zamboanga Fish Port Complex (ZFPC), secured ISO 9001:2015 recertification after passing their respective annual surveillance audit.

The QMS for the PFDA Central Office involves Public Administration covering Project Management while the QMS for the six mentioned RFPs cover Market and Harbor Operation.

The recertification for NFPC, DFPC, GSFPC, IFPC, and LFPC were issued after the surveillance audit conducted by the SOCOTEC Certification Philippines, Inc., a recognized management systems solution provider, in the concerned offices on separate dates from December 18 - 26, 2020.

Meanwhile, certification for the PFDA Central Office and ZFPC were issued by the TUV Rheinland, another established ISO certifying body, after passing the surveillance audit on December 29, 2020.

The ISO certification for government agencies is in line with Executive Order No. 605, Series of 2007 entitled 'Institutionalizing the Structure, Mechanisms and Standards to Implement the Government Quality Management Program, Amending for the Purpose Administrative Order No. 161, Series of 2006.' ISO 9001 is the international standard that specifies requirements for a QMS, which ensures consistency of products and services through quality processes.

The ISO surveillance audit is conducted annually after the first successful certification to ensure that the organization is continuing to comply with ISO standards and usually takes place at the end of each year within the three-year certification cycle.


Automation of PFDA Services

The longstanding plans towards the complete automation of PFDA services have been considerably accelerated by the COVID-19 pandemic. The adoption of the PFDA Computerized Systems was actually put into effect by PFDA Office Order No. 11 (s. 2019) in 2019 which means that prior to the pandemic, the PFDA Portal was already an integral part of the workforce. However, the potential that digitalization offers was not completely realized. The COVID-19 pandemic caused a sudden shift to recalibrate strategies to achieve organizational excellence and empower efficient collaboration across all units of PFDA as we settle on a sustainable new normal.

Led by the Corporate Planning and Management Information Services Department – Information Technology Division (CPMISD-ITD), the establishment of the portal is in line with the agency's commitment to develop the automation of various internal services that will provide better services to its employees, clients, stakeholders, and the general public.

As of this year, the computerized services included in the PFDA Corporate Information Systems Portal are the following: Administrative Management Information System, Preventive Maintenance System, Daily Time Record System, Document Tracking System, IT Support Ticketing System, Acknowledgement Receipt for Equipment System, Integrated Corporate Reporting System, Online Contract Monitoring System with Client Mapping, Project Monitoring System, and Key Performance Indicator.

In the years to come, the PFDA plans to bring the digitalization of systems to all its Regional Fish Ports to make services more efficient and organized.





ON THE OPERATION OF THE FISH PORTS AND OTHER FISHERY POST-HARVEST FACILITIES



Pursuant to its mandate, PFDA sustained the operation of the nine (9) Regional Fish Ports (RFPs) namely, the Navotas, Iloilo, Zamboanga, Camaligan, Lucena, Sual, Davao, General Santos, and Bulan Fish Ports. The fish port located in Tacloban, Leyte is under the joint management of PFDA and the LGU.

As of December 31, 2020, the total volume of fish unloaded at the regional fish port complexes maintained by PFDA reached a total of 558,288 metric tons (mt). General Santos and Navotas Fish Port Complexes were the two (2) biggest contributors to fish unloadings. Of the total, 51% was handled by General Santos Fish Port Complex (GSFPC), 34% by Navotas Fish Port Complex (NFPC), while the remaining 15% was contributed by the other seven (7) regional fish ports. The total number of fishing and non-fishing vessel arrivals reached 81,811.

Insofar as processing activity is concerned, 2,931 mt of fishery products were processed in the refrigeration facilities of General Santos, Zamboanga, and Camaligan Fish Ports. Moreover, the total volume of ice produced at Zamboanga, Davao, General Santos, and Camaligan Fish Ports was recorded at 31,290 MT.

As of date, PFDA constructed one hundred thirtyfive (135) fish ports nationwide. Of this total, one hundred twenty-five (125) fish ports have been turned over to Local Government Units (LGUs) and eight (8) fish ports are for turn-over. One fish port (Bulan FP) is under PFDA management while one fish port (Tacloban FP) is under joint management of PFDA and the LGU.

In line with the government's privatization scheme, PFDA continued to lease out four (4) ice plants and





cold storages to the private sector located in the provinces of Masbate, Negross Occidental, Sultan Kudarat, and Surigao del Norte.

Regional Fish Ports Program

The Regional Fish Ports Program involves the provision and operation of fish port complexes in strategic fish landing centers nationwide. These fish ports are equipped with facilities such as breakwater, landing quay, market halls, refrigeration and processing facilities, slipway, and related facilities. In particular, the program addresses the needs of the commercial fishing boat operators, municipal fishermen, and fish processors/exporters, among others.


Municipal Fish Ports Program

The Municipal Fish Port Programs caters to the postharvest requirement of sustenance fishermen. It entails the provision of smaller fish landings and market facilities in selected fishing communities nationwide. Some of these municipal fish ports act as satellite ports for the regional fish ports. The PFDA provides the needed training on port operations and maintenance for the eventual turnover of the ports' management to the Local Government Units (LGUs).

Ice Plants and Cold Storage Program

The Ice Plants and Cold Storage program helps satisfy the ice requirements of the fishing industry. It involves the provision of ice making machines of different magnitudes and cold storages of varying capacities.






NAVOTAS FISH PORT COMPLEX

The Navotas Fish Port Complex (PFDA - NFPC) is the first major fish port and fish market complex placed under the jurisdiction, control, and supervision of the Philippine Fisheries Development Authority (PFDA). It is situated in a 49-hectare land in the eastern portion of the Manila Bay and is considered the premier fish center of the Philippines and one of the largest in Asia. It provides fish and fishery products to markets and institutional buyers in the metropolis and other parts of Luzon.

Ever since, PFDA- NFPC has been providing facilities for harbor operations including drydocking, fishing gear repair, ice, water and fuel conveyance and product transshipment. It is also considered a major site for unloading and marketing of fish both from commercial and municipal fishing vessels. The port's ISO 9001:2015 certification shows that it has been continuously enhancing its facilities and services by providing quality harbor and market operation services to its growing number of clients and customers.

The port

complex is currently undergoing rehabilitation and modernization to transform it into a modern integrated trading hub for various agri-fishery commodities. The project entails the expansion and elevation of unloading stations, repair of road networks and drainage systems, and establishment of state of the art cold storage facilities. These improvements are expected to further elevate the capacity and services of the fish port complex, thereby benefiting the entire fisheries sector of the country by ensuring food security and stability for the years to come.



ILOILO FISH PORT COMPLEX

The Iloilo Fish Port Complex (PFDA - IFPC) is located in a 21-hectare reclaimed area at Barangay Tanza, Iloilo City in Visayas. It serves as the regional fish port in Region 6 (Western Visayas) with a vast area of raw land that is open for lease for the establishment of commercial spaces, communication facilities and agri-fishery related factories. It caters to all types of municipal and commercial fishing boats.

The port complex is a traditional landing site of bagnetters and other fishing bancas in Iloilo City and nearby towns. Its strategic location as an inter-island port with a natural harbor made it an ideal location for trade and industry. As it became modernized, it began accommodating unloading and marketing facilities for fish and other fishery products for both local and foreign markets. In addition, the port now also provides post-harvest services including processing, refrigeration, product pre-processing, freezing through contact freezer, cold storages and top-grade facilities for the processing of marine products. Through the years, the port's unfaltering efficiency and competency has led to its attainment of ISO 9001:2015 certification in 2018.

The ongoing renovation and improvement of the PFDA - IFPC is expected to contribute to a more competitive fishing industry in the entire Visayas region by attracting more investors and locators, particularly fish processors, by providing more income and employment for fisherfolks and their families.



ZAMBOANGA **FISH PORT COMPLEX**

The Zamboanga Fish Port Complex (PFDA - ZFPC) is situated in a 12.5-hectare complex in Barangay Sangali, Zamboanga del Sur. It is considered the largest marine products processing center in Region 9. The diverse and high quality marine products that are being produced at the port led to the restrengthening of trade links in Western Mindanao and their neighboring towns and provinces, a trading partnership that has existed since the 17th century.

The establishment of Zamboanga Fish Port Complex (ZFPC) in Western Mindanao further strengthened these linkages by providing the fishing industry in the region with a systematized fish marketing and distribution system. Because of the port's unrivaled efforts in providing products and services that meet customer and regulatory requirements in the region, it was able to achieve its ISO 9001:2015 certification in 2019.

The PFDA-ZFPC is set to undergo renovation and improvement which involves the construction of a fishery complex, a fish-processing unit, administrative blocks, a warehouse complex, a logistics terminal, a cold storage, housing units for employees, powerrelated facilities, and the installation of safety and security systems. This project will greatly benefit the flourishing fisheries sector in the region by providing better facilities for the fisherfolks, vessel operators, fish brokers, traders and processors, storage and ice plant operators, and agricultural support groups working in the region.



CAMALIGAN **FISH PORT**

The Camaligan Fish Port (PFDA-CFP) is built on a 4-hectare property in Barangay Dugcal, Camaligan in Camarines Sur. It is the fourth major fish port project completed under the Nationwide Fishing Ports Projects Package I.

The PFDA-CFP has been identified as a fish processing complex, providing facilities and services to private fish processors since its establishment. It extends its services to the entire Bicol Region in terms of efficient handling and distribution of fish and fishery products. The port provides necessary post-harvest facilities to ensure that newly-hauled fish and other fishery products are handled properly and expeditiously at least costs.


Some of the services that it offers include the use of unloading and marketing facilities for fish and other fishery/aquatic products both for local and foreign markets; provision of facilities for harbor operations such as ice, water and fuel conveyance and product transshipment; lease of processing and refrigeration facilities including pre-processing, product preservation through cold storage and contact freezer; information dissemination regarding fish prices, volume of processed products, species unloaded and volume of unloadings; and lease of office spaces and raw land for establishment of fishery-related factories.



LUCENA FISH PORT COMPLEX

The Lucena Fish Port Complex (PFDA-LFPC) is located in a 7.8-hectare reclaimed area at Barangay Dalahican in Lucena City, Quezon. It has been playing an important role as a regional fish port serving both commercial and municipal fishery as well as commercial boats, thus greatly contributing to the economy of Region 4A (CALABARZON).

The port complex offers its facilities for harbor operations, such as drydocking and repair; provision of fuel, oil, water and ice supplies for product transshipment; lease of raw land for establishment of fishery-related factories; and refrigeration and other post harvest services, including freezing through contact freezing and product preservation using cold storages.

It is currently

being developed under the Nationwide Fish Ports Project Package III of the government. The development includes the construction, rehabilitation and improvement of the fish port's existing facilities, such as pier, market hall, cold storage, ice plant and wastewater treatment plant.

New facilities will be established and new equipment will be procured.



SUAL FISH PORT

The Sual Fish Port (PFDA-SFP) is constructed on a 3.8-hectare reclaimed land located at Poblacion, Sual in Pangasinan. It is one of the fish ports under the Fishing Ports Project Package I of the PFDA. It was established for the unloading of rich marine products of Lingayen Gulf and the waters of the western coastline of Pangasinan and the harvests from the province's vast inland resources.

Prior to its role as a major regional fish port, it was already a thriving seaport with trade links to other Asian neighbors. It currently plays a significant role as the only transshipment port in northern Luzon, not only for fish caught in Lingayen Gulf, but also for general commodities to Dagupan City, the center of commerce and marketing in Pangasinan province. Its proximity and accessibility from Metropolitan Manila makes it a highly suitable and viable area for the booming fisheries industry in north and central Luzon. The renovation and improvement project of the PFDA-SFP aims to accommodate bigger fishing boats and cargo vessels. As a strategically-sited landing point, the modernization of the port is critical to the full development of the fisheries sector of the country.








DAVAO FISH PORT COMPLEX

The Davao Fish Port Complex (PFDA-DFPC) is a 4.5-hectare fish port complex situated in Daliao, Toril District in Davao City. Established in 1995, it is the seventh commercial fish port operated and administered by the PFDA. It is the second major fish port complex established in the Mindanao area, next to the Zamboanga Fish Port Complex. During its initial year of operation, the DFPC has become attractive to foreign long-line vessels thereby making it an alternative transshipment port in the Asia Pacific Region.

Aside from the standard and basic port operations of berthing and unloading of fish caught by domestic fishing vessels, the PFDA – DFPC also serves as a hub for the collection, processing, storage, and packaging of fish and fishery products for distribution to both domestic and export markets. The ongoing rehabilitation and improvement of PFDA-DFPC is expected to support the region's growing agro-industrial sector, spurring further economic growth in Mindanao. Given its strategic location and current role as a regional fish port complex, the improvement and modernization project is expected to enhance the country's socioeconomic integration with other major trading hubs in the Asia-Pacific region.

GENERAL SANTOS

FISH PORT COMPLEX

The General Santos Fish Port Complex (GSFPC), covering an area of 11 hectares, is located in Barangay Tambler, General Santos City in South Cotabato. It provides fishery post-harvest facilities for commercial and municipal fishing vessels, market traders, processors and exporters in SOCCSKSARGEN (Region 12) in Mindanao.

The fishing industry in the region is primarily centered in General Santos City, supporting thousands of jobs and generating millions in foreign exchange earnings. In the 1970's, General Santos City earned the moniker "Tuna Capital of the Philippines" because of its role as a major producer and exporter of tuna in the country and in Asia Pacific. Since then, the PFDA-GSFPC has catered to the robust tuna industry as the primary provider of post-harvest facilities and infrastructure that facilitates the handling, trading and distribution of tuna and other fishery products in the country.

GSFPC PFDA attracts investors involved in an array of economic interests, among which are some of the largest companies in the Philippines' fishery sector. As a major fish port in the Philippines, the modernization and expansion of PFDA - GSFPC is expected to increase food sustainability and resilience and to enhance the global competitiveness of the country's flourishing fisheries sector.



BULAN FISH PORT COMPLEX

The Bulan Fish Port Complex (PFDA - BFPC) is the youngest Regional Fish Port added under the management of the PFDA. In 2017, PFDA - BFPC was officially upgraded from a municipal fish port to its current Regional Fish Port (RFP) status. It is located in Bulan, Sorsogon, the south-westernmost tip of Luzon Island, making it accessible to fishing boats and fish investors alike. It has a wide area of influence due to its strategic location, and is presently thriving with commerce coming from Northern Samar, Masbate, and Leyte. Aside from its role as a Regional Fish Port, the PFDA - BFPC jointly manages the operations of Tacloban Municipal Fish Port (TMFP) in Leyte with the local government unit concerned.

One of the key improvements made for the PFDA – BFPC was the expansion project to accommodate new facilities such as ice stalls, food stalls, banyera warehouse, a spacious parking area, and bigger market halls. Through this expansion project, it is expected that the PFDA – BFPC will attract more business opportunities and encourage more investors to transact at the port. During its planning stage, among the target beneficiaries of this project are the existing locators operating inside which started business since the start of operations as a municipal fish port. Aside from these locators, more than 1,500 registered fishing vessels, serving as the main source of livelihood to more than 6,413 individuals, are taking advantage of the newly improved PFDA - BFPC.

The expansion project also resolved the PFDA -BFPC's perennial problem as a previous MFP like congestion in the landing quays and insufficient market hall space.

COVID-19 RESPONSE



Defying challenges amid the COVID-19 pandemic

The COVID-19 pandemic and the imposition of protracted community quarantine caused a massive economic disruption in the country, leading government agencies like PFDA to make a rapid transition and take new approaches to operational strategies. As an attached corporation to the Department of Agriculture, the PFDA has to continuously ensure unhampered supply of fish, unloading, and trading operations in all the PFDA Regional Fish Ports while maintaining food safety across the country.

When the lockdown started last March, food supply chains were strained when the government imposed restrictions on movement of goods and people across and within regions. As a result, access by the consuming public to food such as fish and other fishery products was challenged. However, the PFDA rose up to the challenge through its flagship CSR project "isDA ON THE GO" which provided cheap and quality fish and fishery products to consumers living in Metro Manila and nearby provinces. The construction, rehabilitation and improvement of PFDA RFPs remained unhampered and are still set to be finished in record time.

The PFDA also adapted infection control strategies based on recommendations from the Department of Health. Necessary precautions and proper care had to be established to ensure the safety of all employees. The PFDA continues to observe elevated cleaning and sanitizing protocols by conducting regular disinfection and general cleaning services of the entire port premises and

The PFDA Cental Office and Regional Fish Ports conducted strict monitoring on minimum safety and health protocols by the IATF:

- compliance with ID and passes;
- thermal scanning;
- provision of alcohol, sanitizer, and face mask for frontline employees;
- observance of physical distancing;
- installation of misting and sanitation tents in RFPs; and
- conduct of regular disinfection of the RFPs and the Central Office

facilities. Close coordination and collaboration with Local Government Units (LGUs), uniformed personnel, and port clients on health protocols were undertaken. Various measures are also followed by all the personnel and clients to prevent the further spread of the disease such as proper and regular wearing of face masks and shields, temperature monitoring, enhanced sanitation by installing foot baths and alcohol dispensers are also being done, frequent thorough hand-washing and sanitation, and observance of physical distancing at all times.

The PFDA Regional Fish Ports (RFPs) and the Central Office are constantly conducting their monthly general cleaning to assure safety and security of everyone in the port's vicinity against the virus. PFDA-CO also adheres to the government's guidelines of adopting a 30% to 50% on-site capacity and implementing a work-from-home set up for its staff and personnel to provide service to all stakeholders and the public. Above everything else, PFDA ensures the safety of its employees, clients, and the public.

Implementation of standard health protocols and measures against the spread of the coronavirus disease has been part of the "new normal" in all PFDA units. As one of the government agencies in the food production sector particularly mandated to provide fishery post-harvest facilities, the PFDA continues to ensure a safe working environment for its workforce and clients.

PFDA Bulletin

For its maiden episode, PFDA Bulletin tackled "Health Updates: Dealing with COVID - 19 in the Workplace", August 19. Dr. Maritoni Jane A. Catan, PFDA Medical Consultant, served as the resource person for the topic. The second episode of the PFDA Bulletin provided updates on "isDA ON THE GO". The episode also tackled the importance of ensuring food safety amid the pandemic, from the production, distribution, storage, preparation, and consumption of fish and fishery products. Ultimately, the Food Safety and Environment Management Unit (FSEMU) discussed their role as the local monitoring and coordinating body of the PFDA on concerns pertaining to compliance on food safety, proper waste management, pollution control, and other relevant fisheries and environmental laws.

The PFDA team conducted a site visit to San Andres Aquaculture Corporation (SANACOR) in Alabel, Sarangani Province, July 22, 2020. SANACOR contributes to an average production of 10,000 metric tons of high value catch like pompano, sea bass, shrimps and milkfish in the province. Aside from SANACOR,





Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of the Philippine Fisheries Development Authority (PFDA), which comprise the statements of financial position as at December 31, 2020 and 2019, and the statements of comprehensive income, statements of changes in equity and statements of cash flows for the years then ended, and notes to financial statements, including a summary of significant accounting policies.

In our opinion, except for the possible effects of the matters described in the Bases for Qualified Opinion section of our report, the accompanying financial statements present fairly, in all material respects, the financial position of PFDA as at December 31, 2020 and 2019, its financial performance, changes in equity, and cash flows for the years then ended in accordance with Philippine Financial Reporting Standards (PFRS).

Bases for Qualified Opinion

The Construction in Progress (CIP) account with balance amounting to P1.307 billion as at December 31, 2020 was overstated by P375.331 million due to the inclusion of: (a) six completed projects totaling P254.662 million; (b) seven on-going projects totaling P119.075 million which are intended to be transferred to Local Government Units (LGUs) and Bureau of Fisheries and Aquatic Resources upon completion; and (c) administration and other overhead costs incurred totaling P1.594 million as part of the project costs, contrary to the description of this account under Annex C of Commission on Audit Circular No. 2020-002 dated January 28, 2020 and paragraph 19 of the Philippine Accounting Standard (PAS) 16. The three projects with Notice to Terminate Contract, one project with Notice of Decision and one project under litigation with project costs totaling P140.648 million, P11.083 million and P10.470 million, respectively, were not disclosed in the Notes to Financial Statements, hence, reduces the faithful representation of the financial statements.

The Investment Property account with the carrying value of P118.457 million is understated by: (a) an estimated sound value of P533.160 million of the unrecorded parcels of land measuring 68.7 hectares in three PFDA fish port complexes; and (b) an undetermined market value of the 37.9 hectares of land area where the PFDA operates its major fish ports in four locations in the country, contrary to Paragraph 16 of PAS 40.

2020 **AUDITED FINANCIAL STATEMENT**

We were unable to obtain sufficient appropriate audit evidence about the balances of the Investment Property account due to inadequacy of the accounting and property records on the unrecognized parcels of land. Consequently, we were unable to determine whether any adjustments to these amounts were necessary.

We conducted our audits in accordance with International Standards of Supreme Audit Institutions (ISSAI). Our responsibilities under those standards are described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the PFDA in accordance with the Revised Code of Conduct and Ethical Standards for Commission on Audit Officials and Employees (Code of Ethics) together with the ethical requirements that are relevant to our audit of the financial statements, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Responsibilities of Management and Those Charged with Governance for the **Financial Statements**

Management is responsible for the preparation of the financial statements in accordance with PFRS, and for such internal control as management determined is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management's responsibility for assessing the PFDA's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the PFDA or to cease operations, or has no alternative but to do so.

Those charged with governance are responsible for overseeing the PFDA's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements, as a whole, are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISSAI will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISSAI, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

· Identify and assess the risks of material misstatement of the financial statements, intentional omissions, misrepresentations, or the override of internal control.

whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery,

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the PFDA's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- · Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the PFDA's ability to continue as a going concern. If we conclude that a material uncertainty exists. we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the PFDA to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit observations, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence and, where applicable, related safeguards.

Report on Other Legal and Regulatory Requirements

Our audits were conducted for the purpose of forming an opinion on the basic financial statements taken as a whole. The supplementary information in Note 26 to financial statements is presented for the purpose of filing with the Bureau of Internal Revenue and is not a required part of the basic financial statements. Such supplementary information is the responsibility of management and has been subjected to auditing procedures applied in our audit of the basic financial statements. In our opinion, except for the effect of the information of the matters described in the Bases for Qualified Opinion paragraph, the supplementary information is fairly stated, in all material respects, in relation to the basic financial statements taken as a whole.

PFDA WHISTLEBLOWING POLICY

PFDA is committed to uphold the highest ethical standards in public service. Its officials and employees shall at all times be accountable to the people and shall discharge their duties with utmost responsibility, integrity, competence and loyalty.

Coverage

These guidelines shall cover all PFDA officials and employees.

Disclosures from non-PFDA employees shall be dealt in accordance with pertinent existing laws, rules and regulations on whistleblowing/reporting issued by competent authorities.

Definition of Terms

Whistleblowing is the disclosure of and/or giving of evidence to information that a whistleblower reasonably believes constitutes graft and corrupt practices or any illegal doings.

Protected Disclosure refers to the deliberate and voluntary disclosure by an official or employee who has relevant information of an actual, suspected or anticipated wrongdoing.

A Whistleblower refers to any PFDA employee or group of employees who makes protected disclosures.

Retaliatory Action pertains to negative or obstructive responses or reactions to a disclosure of misconduct or wrongdoing taken against the whistleblower and/or those officials and employees supporting him/her.

It shall be the duty of all PFDA officials or employees who witness or become aware of any attempted, ongoing or consummated act of graft and corrupt practices involving any PFDA official or employee to report the same at the earliest possible time to:

- The General Manager or his duly authorized representative
- To the Chairman of the Board of Directors, if the official involved is the General Manager

Rights of a Whistleblower

- No administrative action shall be entertained or pursued by ٠ the Agency against any PFDA official or employee who make disclosures or reports deemed protected under these Office Order.
- A whistleblower shall be protected from retaliatory actions.
- A whistleblower that has an obligation by way of oath, rule or practice to maintain confidentiality of information shall not be liable for the breach of confidentiality if he/she makes a protected disclosure of such information.
- Any official or employee who refuses to follow orders to perform an act that would constitute a violation of this provision shall likewise be protected from retaliatory actions.
- At all times during and after the protected disclosure, and throughout and after any proceeding taken thereon, the whistleblower is entitled to confidentiality as to: his/her identity; and the subject matter of his/her disclosure.

Protection of Witnesses

Any official or employee who testifies in any proceeding arising from a protected disclosure shall have the same rights as that of the whistleblower.

Assistance to the Whistleblower

PFDA shall grant legal assistance to the whistleblower if the need arises and in cases of grave threats to life and/or safety, appropriate action shall be taken for the protection and support of the whistleblower.



The whistleblower shall be entitled to protection and assistance under this Office Order after the investigation conducted showed valid basis and provided that all the following requisites are fulfilled:

- The whistleblower has personal knowledge of facts and information covered by the disclosure;
- The disclosure is made voluntarily, in writing and under oath;
- The disclosure pertains to a matter not yet the subject of a complaint already filed with, or investigated by concerned Department/Unit of PFDA unless the disclosure is necessary for the effective and successful prosecution, or necessary for the effective and successful prosecution, or would constitute a material evidence not yet in the possession of the Agency;
- The whistleblower formally undertakes to assist and participate in proceedings commenced in connection with the subject matter of the disclosure;
- The information given by the whistleblower contains sufficient particulars and, he/she submits or undertakes to submit material evidence that may be in his/her possession.

Immediately upon receipt of the disclosure, the General Manager, or the official he may designate, shall:



Disclosure Made by a Party to an Act Being Reported

A disclosure made by an officer or employee who is a party to the act being reported may be deemed protected disclosure and maybe entitled to all the rights provided herein, subject to the following: a) The whistleblower complies with the conditions set herein;

- b) The whistleblower should not appear to be most guilty;
- c) The whistleblower testifies in accordance with his/her-disclosure;
- d) The disclosure is necessary for the proper prosecution of the act.

Unprotected Disclosure

The following shall not be deemed protected disclosure under this Office Order:

- Disclosure concerning merits of office policies; Disclosures made by an official or employee in connection with a matter subject of his official Absolutely false and misleading disclosures; Disclosures that are later retracted by the investigation; and
- whistleblower for any reason.
- An official or employee who makes a disclosure Disclosures which later appear to be absolutely deemed unprotected shall not enjoy any groundless or without basis. immunity, or other right or privilege accorded
- whistleblower shall be subjected to administrative, civil and/or criminal proceedings.
- administrative cases, civil and/or criminal actions as may be appropriate.
- Any official or employee under obligation to report a disclosure under this Office Order, or who fails to act
- administrative, civil and/or criminal actions, as may be warranted.

Protected Disclosure

Procedure for Protected Disclosure



Conduct appropriate actions in accordance with applicable laws, rules and regulations, should the report qualifies as protected disclosure:



Ensure that all the rights of a whistleblower contained herein are accorded to him/her, should the report qualifies as protected disclosure.

Any official or employee who violates the protection of confidentiality of a protected disclosure shall be subjected to disciplinary and/or criminal action as may be warranted by pertinent laws, rules and regulations. Any official or employee, who does, causes or encourages retaliatory actions as defined herein against the

False, misleading and malicious disclosures shall be sufficient ground for the termination of the protection or assistance to whistleblowers under this Office Order including the termination of their immunity from

thereon or cause an investigation thereof, shall be liable for disciplinary action.

Any official or employee who, with malice or bad faith, makes a false disclosure may be subject to


