

INVITATION TO BID

FOR THE IMPROVEMENT OF PFDA-NFPC ADMINISTRATION BUILDING


1. The Philippine Fisheries Development Authority, through the CY 2024 Corporate Budget intends to apply the sum of Fourteen Million Thirteen Thousand Pesos (₱ 14,013,000.00) being the ABC to payments under the Improvement of PFDA-NFPC Administration Building / NFPC-IPNAB2024. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine Fisheries Development Authority now invites bids for the above Procurement Project. Completion of the Works is required on or before October 31, 2024 / within five (5) months from the issuance of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested Bidders may obtain further information from the Philippine Fisheries Development Authority – Navotas Fish Port Complex and inspect the Bidding Documents at the address given below during Monday to Friday, 8:00 A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on April 16, 2024, from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (₱ 25,000.00) plus 12% VAT. The Procuring Entity shall allow the bidder to personally present its proof of payment of the fees.
6. The Philippine Fisheries Development Authority will hold a Pre-Bid Conference¹ on April 26, 2024, 2:00 P.M. at Ground Floor, PFDA GAD Building, Navotas Fish Port Complex, North Bay Boulevard, Navotas City and/or through video conferencing or webcasting via G-meet, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the Ground Floor, PFDA GAD Building, Navotas Fish Port Complex, North Bay Boulevard, Navotas City on or before May 9, 2024, 12:00 noon. Late bids shall not be accepted.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on May 9, 2024 (Wednesday), 2:00 P.M. at the Ground Floor, PFDA GAD Building, Navotas Fish Port Complex, North Bay Boulevard, Navotas City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Philippine Fisheries Development Authority reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
