- 1. The PHILIPPINE FISHERIES DEVELOPMENT AUTHORITY (PFDA), through the Corporate Funds for 2019 intends to apply the sum of THREE MILLION THREE HUNDRED EIGHTY THOUSAND ONE HUNDRED EIGHTY-FOUR PESOS AND 25/100 PESOS (PhP 3,380,184.25) being the Approved Budget for the Contract (ABC) for one (1) year for the Procurement of Security Services Requirement of Lucena Fish Port Complex (LFPC). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PFDA, through the LFPC Bids and Awards Committee now invites bids for the supply of SIXTEEN (16) security guards including supplies and equipment in accordance with Section VI Schedule of Requirement. The contract shall be for a period of THREE (3) years. Delivery of the Goods is within seven (7) days upon receipt of Notice to Proceed. Bidders should have completed, within the past FIVE (5) years immediately from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II-Instructions to Bidders.
- 3. Bidding will be conducted through open competitive procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise kwon as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to a Filipino citizen, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from PFDA LFPC and inspect the Bidding Documents at the address given below during office hours, from 8:00 am to 5:00 pm. A complete set of Bidding Documents may be purchased by interested Bidders on December 3, 2019 to January 6, 2020 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of PhP FIVE THOUSAND PESOS (P 5,000.00) only.
- 5. The PFDA LFPC RBAC will hold a Pre-Bid Conference on <u>December 10, 2019</u>, at 2:00 PM at the LFPC Conference Room located at the LPFC Administration Building which shall be open to all interested parties who wish to attend.

6. Bids must be delivered to the address below on or before 12:00 Noon, January 6, 2020. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1

The PFDA-LFPC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
