INVITATION TO BID FOR THE PROCUREMENT OF BRAND NEW VEHICLES: TWO (2) UNITS PASSENGER VAN, AND TWO (2) UNITS ALL-TERRAIN VEHICLE (PICKUP VAN)

- 1. The PHILIPPINE FISHERIES DEVELOPMENT AUTHORITY (PFDA), through the Corporate Operating Budget for 2018 approved by the Governing Board intends to apply the sum of SEVEN MILLION TWO HUNDRED THOUSAND PESOS ONLY (₱7,200,000.00) being the Approved Budget for the Contract (ABC) for the procurement of Brand New vehicles: Two (2) units Passenger Van, and Two (2) units All-Terrain Vehicle (Pickup Van). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PFDA, through the PFDA Bids and Awards Committee now invites bids from eligible bidders for the Procurement of Brand New vehicles: Two (2) units Passenger Van, and Two (2) units All-Terrain Vehicle (Pickup Van). Bidders must have presence in the local market for the past three (3) years and completed, within the past three (3) years immediately from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II-Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from PFDA and inspect the Bidding Documents at the address given below during office days, from 8:00 am to 5:00 pm. A complete set of Bidding Documents may be purchased by interested Bidders on November 16 to December 5, 2018 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of ₱ 10,000.00
- 5. The PFDA will hold a Pre-Bid Conference on November 23, 2018 at 10:00 am at 2nd Floor, Room 204 PCA Annex Bldg., Elliptical Road, Diliman, Quezon City which shall be open to all interested parties.
- 6. Bids must be delivered to the address below on or before 12:00 NN on December 5, 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1.
 - Bid opening shall be on December 5, 2018 at 2:00 p.m. at PFDA Conference Room located at 2nd Floor, Room 205 PCA Annex Bldg., Elliptical Road, Diliman, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.
- 7. The PFDA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. The schedule of BAC activities is as follows:
