INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF ONE (1) LOT LAPTOP AND DESKTOP COMPUTERS WITH SOFTWARE LICENSES

(NFPC GOODS-002)

- 1. The Philippine Fisheries Development Authority Navotas Fish Port Complex through CY 2021 General Appropriation Act intends to apply the sum of Two Million Eight Hundred Twenty Thousand Pesos (₱ 2,820,000.00) being the Approved Budget of the Contract (ABC) to payments under the contract for the Supply and Delivery of One (1) Lot Laptop and Desktop Computer Sets with Software Licenses. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Philippine Fisheries Development Authority Navotas Fish Port Complex now invites bids for the above Procurement Project. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from PFDA-Navotas Fish Port Complex and inspect the Bidding Documents at the address given below during office hours, from 8:00 a.m. to 5:00 p,m., Monday to Friday
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on July 21, 2021 from the NPFC Regional Bids and Awards Committee (RBAC) Secretariat at Ground Floor, PFDA Administration Office, Navotas Fish Port Complex, North Bay Boulevard, Navotas City and upon payment of applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of Five Thousand Pesos (₱ 5,000.00) tax exclusive.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the





Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The PFDA NFPC will hold a Pre-Bid Conference¹ on August 2, 2021, 2:00 p.m. at the Ground Floor, PFDA GAD Building, Navotas Fish Port Complex, North Bay Boulevard, Navotas City and/or through video conferencing or webcasting (Google Meet) which shall be open to prospective bidders.
- 7. Bids must be duly received by the NFPC RBAC Secretariat at the Ground Floor, PFDA GAD Building, Navotas Fish Port Complex, North Bay Boulevard, Navotas City on or before 12:00 noon, August 17, 2021. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on August 17, 2021, 2:00 p.m. at the Ground Floor, PFDA GAD Bldg., Navotas Fish Port Complex, North Bay Boulevard, Navotas City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. In observance with the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases protocol on social distancing, only one (1) designated/authorized representative per company shall be allowed to physically participate and/or attend in the conduct of the bidding activities. Bids will be opened in the presence of the bidder's representative
- 10. The PFDA Navotas Fish Port Complex reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
