

On Fish Unloading and Handling

Reports showed that during the January to March 2023 unloading period, the PFDA unloaded 118,419.49 metric tons (MT) of fish which is equivalent to an average daily unloading volume of 1,315.77 MT of fish. Moreover, data showed that the PFDA recorded a slight decline in ice production with 5,327.53 MT. Meanwhile, the PFDA processed 237.98 MT of fishery and non-fishery products.

On Serving Port Clients

During Q1, all PFDA RFPs maintained a positive trend both in the quarterly number of vessel arrivals and the number of clients served. The ports opened their doors to 25,200 vessel arrivals and attended to 10,869 clients throughout the quarter.

PFDA PORT UTILIZATION RATE*

On Port Facilities Utilization

In this quarter, piers and quays recorded the highest utilization rate at 198%. As port rehabilitation moves forward across all RFPs, concerns about the high utilization rate can soon be addressed

On the other hand, as other facilities become functional, utilization of market halls was at 92%, commercial/industrial land was at 87%, and ice-making plants were at 65%.

Also, the utilization rate for processing areas and building spaces reached 58%, while cold storage facilities reached a 55% utilization rate.

The rehabilitation project in the PFDA - Lucena Fish Port Complex (PFDA-LFPC) reached its 100% completion rate in December

Also inching closer to completion are the PFDA – Davao Fish Port Complex (PFDA-DPFC) and the PFDA – Iloilo Fish Port Complex (PFDA-IFPC) with an 88.92% accomplishment rate and an 83.88% accomplishment rate, respectively.

Meanwhile, rehabilitation in the PFDA - Sual Fish Port (PFDA-SFP) continues to move at a faster pace with 63.33% accomplished as of March 2023.

Not far behind are the PFDA - Camaligan Fish Port (PFDA-CFP) and PFDA - Zamboanga Fish Port Complex (PFDA-ZFPC) with a 40.29% completion rate and a 38.90% completion rate, respectively.

Furthermore, the National Caption Region will soon be home to a revamped PFDA - Navotas Fish Port Complex (PFDA-NFPC) as Phase 1 and Phase 2 of the port rehabilitation continue as planned.



IOTG ACTIVITIES

PFDA PRESENTS IOTG FLAGSHIP PROJECT TO COOPS IN REGIONS 6, 8

Philippine Fisheries Development Authority (PFDA) conducted an orientation of the PFDA isDA ON THE GO (iOTG) Flagship Project to registered cooperatives in Regions 8 and 6 as part of the celebration of the Cooperative Development Authority (CDA)'s 33rd founding anniversary, held on March 8 and 28, 2023, respectively via teleconference.

The online webinar aims to share programs and services that can be availed by cooperatives the regions through CDA partner agencies, which includes the PFDA's iOTG program.

Mr. Antonino Carlos O. Del Prado of the PFDA – Operations Services Department (OSD) presented the objectives and operations of the iOTG Program for the cooperatives in Region 8. Meanwhile, PFDA-OSD Regional Municipal Port Operations Division (RMPOD) Chief Ms. Janet T. Manalo presented the Program to coops in Region 6.


During the discussion, they discussed the project's business model, product lines (frozen fish and fresh fish), and distribution channels.

In addition, they presented the accomplishments and ways forward of the iOTG program, as well as the roles and responsibilities of PFDA and the cooperatives when the partnership occurs.

Since the collaboration between the PFDA and CDA began in October 2021, the iOTG program has assisted more than 50 cooperatives in Luzon, Visayas, and Mindanao by providing them with top-of-the-line inverter chest freezers, which they utilize for selling fresh-frozen fishery products under the iOTG initiative.

After the orientation, Ms. Manalo answered all queries from coop participants.

PFDA, RFPs JOIN 2023 NATIONAL WOMEN'S MONTH **CELEBRATION**

Philippine Fisheries Development Authority (PFDA), through the PFDA Gender and Development Focal Point System (PFDA-GFPS), joined the celebration of the 2023 National Women's Month Celebration (NWMC) with the theme "WE for gender equality and inclusive society" this March 2023.

During a kickoff event on March 6, 2022, the PFDA launched its participation in the monthlong observance, aiming to motivate women and everyone (WE) to push equality and inclusivity where all, regardless of ability, status, and situation, are respected and afforded their rights.

In her opening speech, PFDA Officer-in-Charge General Manager and PFDA-GFPS Executive Committee Chairperson Ms. Iris R. de Vera recognizes the dedication of every female employee in the Central Office and in the Regional Fish Ports who are passionately working to assist our resilient Filipino fisherfolk.

Some activities include a Women's Month parade and the distribution of GAD reading materials. In addition, the PFDA-NFPC launched an exhibit entitled "HER Story: Outstanding Women Exhibit" that celebrates the work, achievements, and historical significance of remarkable Filipinas. Afterward, the color purple which symbolizes women's empowerment and gender equality illuminated the night during the ceremonial lighting of the PFDA-NFPC GAD Center Building.



Subsequently, staff and personnel of the PFDA -Zamboanga Fish Port Complex (PFDA-ZFPC) led by Port Manager Ignacio M. Yao joined the "Marcha de Las Mujeres: A Purple Walk for a Cause Campaign" organized by the City Government of Zamboanga as part of the 113th International Women's Day celebration with the theme "DigitALL: Innovation and Technology for Gender Equality" on March 8, 2023.

The program was attended by staff and personnel of the PNP-Maritime Unit, Philippine Coast Guard, and Bureau of Plant Industry.



Moreover, the PFDA - General Santos Fish Port Complex (PFDA-GSFPC) also took part in the major activities for the NWMC.

One of the highlights of their celebration was the Serbisyo Kay Juana: Year 5 which is a port's collaboration with the Barangay Tambler Rural Health Unit (RHU) which aims to provide health services to women clients of the Port. Such services include free medical check ups and consultations, basic health services such as blood pressure and blood sugar monitoring, HPV vaccination, and distribution of vitamins, medicines, contraceptive pills, and sanitary hygiene kits.

PFDA-GFPS Overall Head and Public Information Division Chief Mr. Mc Christian Julius A. Macaranas II served as the resource person for the orientation.


Mr. Macaranas discussed various topics, including the basics of Sexual Orientation, Gender Identity and Expression, and Sexual Characteristics

PFDA JOINS MARITIME FORUM ON PORT DIGITALIZATION IN PH

Philippine Fisheries Development Authority (PFDA) joined various government maritime agencies and private maritime stakeholders in a forum entitled "Port Digitalization and Modernization: Fueling our way to become an Asian Maritime Hub", held at the Citadines Bay City Manila, Pasay City on March 30, 2023.

Organized by The Manila Times, the assembly firmly calls for full digitalization of the Philippine maritime industry to satisfy global demand for a modernized maritime hub.

Guest speakers from various maritime agencies shared their knowledge and ways forward to accelerate the integrated development of the Philippine maritime industry.

Atty. Mark Jon S. Palomar of the Philippine Ports Authority (PPA) shared the agency's digital infrastructure projects that are aimed to provide seamless services in ports. During his talk, Atty. Palomar presented the PPA's Digitalization Roadmap 2021-2023. He said that the PPA believes that digitalization is the way forward to provide real-time data in one platform, become paperless, and reduce time and cost while increasing transparency, cybersecurity, and market access.

On the other hand, Ms. Mary Ann Pastrana, Chairperson of the Archipelago Philippine Ferries Corporation, presented modernized services offered to their clients and stakeholders. Ms. Pastrana said that digitalization is what people want in an industry that is mostly driven by traditional business models. She noted the need for digital transformation and the incorporation of



technological advancements to further challenge the status quo and promote cultural change.

Meanwhile, Ms. Nannette Z. Villamor-Dinopol, Deputy Administrator for Operations of the Maritime Industry Authority (MARINA), presented the Maritime Industry Development Plan (MIDP) 2028. Ms. Dinopol said that the Plan is consistent with the core principles of the Sustainable Development Goals (SDG) of the United Nations and the principle of "leaving no one behind" as well as the achievement of the long-term vision for the Filipinos to enjoy a strongly rooted, comfortable, and secure life.

Ms. Dinopol believes that the support of the national government and the stakeholders on the implementation of the updated MIDP in the context of a whole-of-nation approach is one of the keys for the Philippines to become a maritime hub in Asia.

Finally, Atty. Brenda Pimentel of The Manila Times talked about how digitization and digitalization can be the key to making the Philippines a maritime hub and the challenges that the country might face along the way.

Representatives from the PFDA Central Office and Regional Fish Ports attended the forum.

Through the PFDA Regional Fish Ports (RFP), the agency is committed to implementing effective port state measures to eliminate IUU fishing activities in order to prevent the unlawful catching of shark and ray species in the country.

PFDA-GSFPC LAUNCHES ALS TUNA ESKWELA FOR OUT-OF-SCHOOL FISH PORT WORKERS

Philippine Fisheries Development Authority – General Santos Fish Port Complex (PFDA-GSFPC), in partnership with the Department of Education (DepEd) and Barangay Local Government Unit of Tambler, launched the Alternative Learning System (ALS) TUNA Eskwela for out-of-school fish port workers, held at the PFDA-GSFPC Food Safety and Environmental Management Unit Building on March 10, 2023.

The ALS center will cater to out-of-school youths (ages 15-24), adult learners (ages 25-64), and those with special needs. Based on an earlier survey conducted by DepEd ALS Tambler District, an initial 15 to 20 students will be accommodated for classes starting this April 2023.

Aside from basic literacy and numeracy, the ALS center also offers specialized courses such as livelihood and skills training, entrepreneurship, values education, and health education, enabling the learners to acquire skills and competencies that can help them become employable or start their own small businesses.

The establishment of ALS Tuna Eskwela is a muchwelcomed development that can change the lives of many fish port workers and provide them with a second chance at education.





PFDA, VARIOUS GROUPS AID FIRE-RAVAGED FAMILIES IN NAVOTAS

Philippine Fisheries Development Authority – Navotas Fish Port Complex (PFDA-NFPC), PFDA Central Office, and PFDA Credit Cooperative joined forces with various groups, companies, and clients, to organize a relief operation for families that were severely damaged by a fire that broke out at the PFDA-NFPC Market 3 on New Year's Eve.

On January 6, approximately 254 fire-affected families received relief packs containing rice, canned goods, drinking water, hygiene kits, school supplies, towels, blankets, clothes, and other household materials that can help them start anew. PFDA-ZFPC ATTENDS 12TH OPEN FISHING SEASON FOR SARDINES

Philippine Fisheries Development Authority – Zamboanga Fish Port Complex (PFDA-ZFPC) attended the commencement of the 12th Open Fishing Season for Sardines following a three-month ban on sardine fishing pursuant to the Bureau of Fisheries and Aquatic Resource (BFAR) Administrative Circular 255, otherwise known as the Establishing of Closed Season for the Conservation of Sardines within Sibuguey Bay, Basilan Strait, and East Sulu Sea, held at the BFAR 9 Conference Hall, Zamboanga City on February 28, 2023

According to BFAR, commercial fishers and small-scale fisherfolk are now allowed to conduct sardine fishing activities following the three-month marine conservation measures for sardines that started on December 1 of last year.



During the fishing ban period, the use of purse seine, bag net, ring net, and scoop net in catching sardines within the area is strictly prohibited to protect the species during its peak spawning season.

The San Pedro Shipyard Corporation, a subsidiary of Montenegro Shipping Lines, Inc., is the present lessee of the PFDA-LFPC's shipyard and workshop facilities. PFDA-LFPC Port Manager Mr. Custodio L. Balaoing Jr. and other staff of PFDA-LFPC attended the launching ceremony of the new passenger vessel that can accommodate almost 500 passengers and 22 freight vehicles.

Aside from the construction of vessels, the shipyard also caters to the repair and maintenance of fishing boats and other passenger and cargo vessels.

The grand launching of M/V Santa Alberta, which was named after their beloved grandmother, coincides with the celebration of National Women's Month 2023. The new vessel will be deployed in Calapan, Mindoro-Batangas (and vice-versa), and is set to contribute to tourism and business activities in the area.



NFPC, ZFPC CONDUCT FIRE SAFETY TRAINING, TACKLE ROLE OF WOMEN IN DISASTER RESPONSE

Philippine Fisheries Development Authority – Navotas Fish Port Complex (PFDA-NFPC), in coordination with the Bureau of Fire Protection (BFP) Navotas City, conducted an orientation on "Fire Prevention and the Role of Women in Disaster Risk Management" as part of the month-long observance of the 2023 National Women's Month and Fire Prevention Month, held at the PFDA-NFPC Gender and Development (GAD) Center on March 22, 2023.
