Enjoy the 2nd Quarter 2024 issue!






PFDA PORT UTILIZATION RATE

On Port Facilities Utilization

The opening of various fishing grounds has influenced the utilization rate of various port facilities this guarter, with piers and guays recording 267% usage in the second guarter. Nevertheless, the PFDA firmly believes that, with the help of ongoing rehabilitation and improvement projects in PFDA RFPs nationwide, this high utilization rate could soon be addressed.

In addition, the usage of market halls and building spaces, commercial, and industrial areas tied up at 85% utilization rate.

Furthermore, the cold storages reached 75% utilization rate, while ice making plants reached 71%, and processing areas with 56% utilization rate.

PFDA CONTINUES ITS JOURNEY ON BUILDING

NEW AND IMPROVED FISH PORTS

The Philippine Fisheries Development Authority (PFDA) is giving a lot of elbow grease in the port rehabilitation and improvement of all PFDA Regional Fish Ports (RFP) in the second quarter of 2024.

Since its completion of redevelopment in 2022, the PFDA - Lucena Fish Port Complex (PFDA-LFPC) allowed its people to serve their customers through their brand-new facilities with fish quality and rightly-priced fish supply.



The PFDA - Davao Fish Port Complex (PFDA-DFPC) is currently in the lead with a completion rate of 99.89%. It will not be long for the DFPC to have a high standard infrastructure that will cater to its clients.



Not far behind, the small but terrible PFDA - Sual Fish Port (PFDA-SFP) is also almost near the completion of a newly improved and redeveloped fish port at the rate of 97.53%.



Furthermore, the PFDA - Iloilo Fish Port Complex (PFDA-IFPC) is on its way to cater to its stakeholders with better quality facilities as the rehabilitation and improvement sits at 91.68% completion rate.



Subsequently, the construction on the two phases of the PFDA - Navotas Fish Port Complex (PFDA-NFPC) is currently in the pipeline. Right now, the average rate of completion for the Phase 1 of PFDA-NFPC is 70.22%, and for Phase 2 is 66.78%.



On the other hand, the PFDA - Zamboanga Fish Port Complex (PFDA-ZFPC) is almost halfway through the development process, with a completion rate of 46.41%.



Moreover, the PFDA - Camaligan Fish Port (PFDA-CFP) is also almost halfway in its rehabilitation with a 45.60% completion rate.



Finally, the improvement of the PFDA - General Santos Fish Port (PFDA-GSFPC) continues in full swing, with Package 1 at 5.03% completion rate and Package 2 at 4.03% completion rate.



PFDA HOLDS BOARD MEETING, INSPECTS ONGOING PORT REHABILITATION IN ILOILO

Philippine Fisheries Development Authority (PFDA) held its first Board Meeting for Fiscal Year (FY) 2024 chaired by Department of Agriculture (DA) Secretary Mr. Francisco "Kiko" P. Tiu Laurel Jr. at the PFDA – Iloilo Fish Port Complex (PFDA-IFPC), Iloilo City on April 5, 2024.

The PFDA team, led by Acting General Manager Atty. Glen A. Pangapalan and Assistant General Manager Ms. Iris R. de Vera, together with the PFDA-IFPC team led by Port Manager Ms. Jovy M. Garrido, warmly welcomed the arrival of Department of Agriculture (DA) Secretary Mr. Francisco "Kiko" P. Tiu Laurel Jr. and the members and representatives of the PFDA Board of Directors.

As the chair of the meeting, DA Secretary Tiu Laurel highlighted the need to continuously improve and modernize the PFDA ports by complying with advanced trading and logistic facilities and a streamlined export process for fishery products.

With the continued support of the PFDA, the Agri chief shared the goal of securing food security through more efficient and cost-effective ways of addressing problems in the fisheries sector. During the meeting, the PFDA presented its FY 2024 project updates, which include the ongoing rehabilitation of the PFDA-IFPC, PFDA – Navotas Fish Port Complex, PFDA – Lucena Fish Port Complex, PFDA – Bulan Fish Port Complex, PFDA – Zamboanga Fish Port Complex, and PFDA – General Santos Fish Port Complex.

Moreover, the agency also i ntroduced the upcoming projects for FY 2025, which include developmental projects under the 'Build-Better-More' infrastructure program and the construction and establishment of Deep Water Ports.

After the meeting, the members of the Board had a quick tour around the port. They inspected the ongoing rehabilitation of the PFDA-IFPC market hall and the newly built cold storage facility.

DA Undersecretary for Fisheries Ms. Drusila Esther E. Bayate, DA Western Visayas Regional Executive Director Mr. Dennis R. Arpia, Bureau of Fisheries and Aquatic Resources 6 Regional Director Ms. Remia A. Aparri, and other board members and representatives joined the Secretary and the PFDA team during the inspection.

PFDA RECEIVES CERTIFICATE OF RECOGNITION IN 2024 GOCC DAY

Philippine Fisheries Development Authority (PFDA) received a Certificate of Acknowledgement of Dividend Remittances during 2024 Government-Owned or -Controlled Corporation (GOCC) Day for its invaluable contribution to Philippine economic development on May 6, 2024 at the Philippine International Convention Center (PICC), Pasay City.

In pursuit of a higher growth path that aligns with the 8-Point Socioeconomic Agenda of President Ferdinand R. Marcos, Jr.'s administration and per Republic Act No. 7656, also known as the Dividend Law, Department of Finance (DOF) Secretary Mr. Ralph G. Recto has requested GOCCs to increase their dividend remittances from a minimum of 50% to 75% on 2023 net earnings.

Led by PFDA Acting General Manager Atty. Glen A. Pangapalan, the agency has remitted P122,239,186.46 in F.Y. 2023.

In his opening message, Mr. Recto thanked the 47 GOCCs for their contributions to driving the country's development agenda forward. According to the Finance Secretary, as of May 6, 2024, the GOCCs have remitted a total of P88.56 billion.

"It is difficult to imagine our economic progress without our GOCCs... They have been the prime movers of our economic development. Maraming salamat po sa inyong suporta at kooperasyon. We assure you that all these contributions will be managed judiciously with utmost transparency and accountability," Mr. Recto said.

Meanwhile, during his keynote speech, President Marcos acknowledged the significant contributions of the GOCCs to the country's economic development. President Marcos thanked the GOCCs for their desire and endeavor to serve the country.





"Thank you for the services that you have rendered and for the dividends you have remitted. Since those dividends also come from the people, let me assure you that they will be carefully spent and will be plowed back to them through projects and programs that will improve their lives today and create a better tomorrow for our children," the President said.

"Your remittances will not only allow our economy to recover, but it would help cut our borrowings and lessen the pressure to inflict higher taxes on the people. Mabuhay ang mga GOCC. Mabuhay ang Bagong Pilipinas," the President exclaimed.

President Marcos led the awarding of the certificates alongside Finance Secretary Recto and Executive Secretary Lucas P. Bersamin.

PFDA, TBI DISCUSS POSSIBLE FISHERY IMPROVEMENT PROJECT COLLABORATIONS



Philippine Fisheries Development Authority (PFDA) Top Management and officials met with representatives from the Tony Blair Institute for Global Change (TBI) and discussed possible collaboration on fishery improvement projects on May 15, 2024, at the PFDA – Central Office Main Conference Room, Quezon City.

PFDA Acting General Manager Atty. Glen A. Pangapalan presented the proposed PFDA's Deep Water Fish Ports Project. These ports will serve as entry and exit points for both fishery and agricultural products that can significantly lower the transportation cost for farmers and fisherfolk.

Department of Agriculture (DA) Undersecretary for Fisheries Ms. Drusila Esther E. Bayate and DA Assistant Secretary for Logistics Mr. Daniel Atayde attended the meeting.





"These proposed projects are expected to rise in strategic locations nationwide. We have projects in the north, east, west, and south seaboard that can provide immediate access and logistical support to fishery and agricultural products. These projects are important because they will benefit the future generation," GM Pangapalan said.

Moreover, the PFDA Deep Water Fish Ports Project is the Agency's answer to President Ferdinand R. Marcos, Jr.'s instruction to ramp up the anti-smuggling efforts and address trading and transport bottlenecks to ensure food security in the country.

TBI Head of Trade & Infrastructure, Mr. Frank Matsaert, and his team showed great interest in the project. Mr. Matsaert said that TBI's vision is to help governments and leaders by providing strategies and insights to help build a prosperous country for all.





Furthermore, on May 16, the TBI team visited the PFDA– Iloilo Fish Port Complex (PFDA-IFPC) and met with the port management led by Port Manager Ms. Jovy M. Garrido to discuss the ongoing port rehabilitation project. Afterward, the team toured the port and its vicinity and paid a courtesy visit to DA Regional Field Office 6 and Philippine Ports Authority – Iloilo.

PFDA SIGNS AGREEMENT WITH SURIGAO CITY LGU TO BUILD REGIONAL FISH PORT

Philippine Fisheries Development Authority (PFDA) signed a memorandum of agreement (MOA) and a memorandum of understanding (MOU) with the Local Government Unit (LGU) of Surigao City on the construction of the Surigao Fish Port Complex on June 21, 2024 at the PFDA – Central Office, Diliman, Quezon City.

This ceremonial signing marks the inception of the construction of the new Surigao Fish Port Complex. PFDA Acting General Manager Atty. Glen A. Pangapalan announced that the project is earmarked as part of the PFDA 2023-2028 Multi-Year Plan.

Moreover, this supports the vision of the Department of Agriculture Secretary Mr. Francisco P. Tiu Laurel, Jr. and President Ferdinand R. Marcos, Jr. to advance the country's agri-fisheries sector through the development of world-class fishery post-harvest facilities.





Surigao City Mayor Hon. Pablo Yves L. Dumlao II warmly welcomed this partnership and thanked the PFDA for its continued support of the fishing industry in the province. Mayor Dumlao proudly noted that Surigao City is a logistics highway between Visayas and Mindanao, making it a viable and strategic agricultural hub.

The establishment of the Surigao Fish Port Complex could potentially offer various benefits to Surigao City LGU, including:

- 1. Ensure food security and accessibility to affordable and nutritious food;
- Increase revenue through business and real property taxes and fees from permits and licenses;
- 3. Create jobs for residents during the construction and port operation;
- 4. Diversify the economy by attracting new businesses in the fishery sector, which may reduce dependence on a single industry and increase economic resilience; and
- 5. Improve fishery product quality and decrease postharvest losses.

As part of the MOU and MOA signing, GM Pangapalan instructed the creation of a Technical Working Group composed of PFDA and Surigao City LGU officials to oversee the construction and port operations and management of the much-anticipated project.

Moreover, Phase 1 of the project is expected to start this year. This phase includes reclamation and marine works, construction of a pier, market hall, administration building, material recovery facility, new public comfort room, entrance/exit arc, and a guard house.

Officials from the PFDA and Surigao City LGU witnessed the signing.

t's 6 o'clock in the evening; the noise of the crowd, the sizzle of hot pans and grills, and the aroma of savory, delicious seafood meals arise as the city folk and tourists alike, patrons and first-timers go to each stall to feast on freshly cooked catches of the day in what the llonggos called; the Paluto sa Iloilo Fish Port.

Starting from small coffee vending stands sheltering under foldable tents, catering only to viajeros, let's dig into this modern culinary experience of what is now an ambient gastronomical hot spot in the Philippines.

THE PALUTO

"The Paluto started really from humble coffee vending." Dr. Justo S. Anaquita Jr., Chief of Harbor Market Operations Division, Philippine Fisheries Development Authority-Iloilo Fish Port Complex (PFDA-IFPC) said in an interview. He explained that the Paluto originally started from a coffee vending shop housed in a foldable tent to address the need of the fisherfolk -or as the locals call the viajeros- for a coffee and eventually into light snacks. After their operation, vendors would just simply fold and clean the tents. From that, Dr. Anaquita witnessed the continuous organic growth of the Paluto from coffee vending into a sort of a "neighborhood" of eateries.

"Dinadayo na yung food vendors natin." Ms. Mona Barbara J. Brodit, Fishery Market Operation Supervisor-designate, PFDA-IFPC, explained in an interview that the emergence of call centers near the vicinity, and hungry travelers and their need for fresh and hot meals affected the growth of the market, paving the way into what we know today as the Paluto sa Iloilo Fish Port.

THE EATYMOLOGY

"Actually we picked that term from the people who are really customers [here]. I think that's their way of describing the activity; the food servicing here. The Paluto." Dr. Anaquita said in telling the origin of the name. He added that after the customers continually use the word "Paluto" in describing the service in the place. He also added that they decided to adapt, connect, and attach the words "Iloilo Fish Port Complex" to the word "Paluto" hence the name "Paluto sa Iloilo Fish Port Complex".

FROM PORT TO PLATE. TO YOU

The process of the Paluto is simple:

- 1. The fishery products are sourced from different fishing grounds; from Palawan to Visayan Sea, even from Mindanao.
- 2. The fishery products will go through the market halls; this is where the fishery products are bought in bulk by the fish retailers.
- The customers will buy the fresh fishery products to 3. the fish retailers.
- 4. The customers will bring the products from the fish retailers and have them cooked by whichever food stalls they like. In about 15 minutes, hot and fresh food is served for customers to enjoy.

OVERCOMING CHALLENGES

"I think we have to accept that we were really caught flatfooted on the very fast development and demand for the food." Dr. Anaquita said. He added "that's why now we are really trying to respond to that pace by making the surrounding environment conducive to that activity."

With approximately 2,000 customers per night, Dr. Anaquita stated a few problems in the Paluto: the high number of people; its consequences regarding the solid waste management and maintaining hygiene. Also the inclement weather conditions. Although demanding, Dr. Anaquita assured that PFDA-IFPC is doing its best in mitigating and managing those said problems. He added that the PFDA management are working together for the realization of a structure that could house the present and future food stall owners and fish retailers, so that customers can come to the place and be comfortable while enjoying their food despite the inclement weather conditions.

FROM LOCAL. TO LOCAL

Every night, the 28 stalls of the Paluto sa Iloilo Fish Port Complex cater to almost 1,000 to 2,000 customers to gather and enjoy the fishery produce from the port. The gospel of the Paluto sa lloilo Fish Port spread to not just Filipinos but also to people from other parts of the world as foreigners can be seen enjoying our local produce.

FROM

In 2023, Iloilo City was awarded the City of Gastronomy by UNESCO Creative Cities Network (UCCN). Dr. Anaguita expressed his appreciation for the award as it is a reflection of the rich culture and the culinary ingenuity that is inherent in the Paluto sa Iloilo Fish Port.

Global recognition is good, but ultimately it all comes down to just savoring the experience and the fresh food that the Paluto sa Iloilo Fish Port provides. And what's better is that it is greatly beneficial to the people who made the Paluto as it is today because other than generating income, the quality of lives of the food stall owners and fish retailers improved.

"It (the Paluto) generates income for these people. And if they have this stable income, they would translate it to a good provision for their families, their education, their employment, and the improvement of the quality of their lives." -Dr. Anaquita

Dr. Anaguita also noted the importance of introducing to the tourists the experience that is original to the llonggo culture, specifically the wide array of local fishery products ranging from crustaceans to high-value fishes.

Additionally, Dr. Anaquita assured the food vendors that the PFDA-IFPC is working hard for the development and the expansion of the port. Furthermore, he hopes that the people understand that the management is doing whatever they can for the good of the people and the port.

MANAMIT NA, BARATO PA! (DELICIOUS, YET AFFORDABLE)

On February 21, the OSD-QAD partnered with the Food Safety and Environment Management Unit (FSEMU) of the PFDA – Iloilo Fish Port Complex (PFDA-IFPC) in the conduct of the orientation on the Check F.R.E.S.H. campaign.





- Meanwhile, on March 13, the OSD-QAD, in coordination with the FSEMU of the PFDA – Bulan Fish Port Complex (PFDA-BFPC), led the soft launching of the Check F.R.E.S.H. Campaign in the port as part of their Orientation on Food Safety, Environmental Management, and Current Good Manufacturing/Handling and Storage Practices.
- Moreover, on April 3, the OSD-QAD visited the PFDA Zamboanga Fish Port Complex (PFDA-ZFPC) and collaborated with the port's FSEMU to facilitate an introductory orientation of the Check F.R.E.S.H. campaign, which was actively participated by fish brokers/traders, food stall operators, cold storage clients, janitorial staff, and port employees.
- The Check F.R.E.S.H. campaign aims to promote food safety and sanitation measures in RFPs based on the insights and preferences of port clients and stakeholders. Through this campaign, the PFDA aims to persuade fish port clients that achieving safer fish ports is possible through cooperation and positive reinforcement.

PFDA PARTICIPATES IN 17TH PTUNASTAT REVIEW WORKSHOP

Philippine Fisheries Development Authority (PFDA) attended the 17th PTUNASTAT Annual Catch Estimates Review Workshop, held on May 23 to 24, 2024, in Tagaytay City, Cavite, to improve the accuracy and reliability of annual tuna catch estimates in the Philippines.

The National Fisheries Research and Development Institute (NFRDI) organized the annual activity in collaboration with the Bureau of Fisheries and Aquatic Resources (BFAR), the Secretariat of the Pacific Community (SPC), and the Western and Central Pacific Fisheries Commission (WCPFC).

In a show of productive collaboration, key stakeholders, including government agencies, industry representatives, and relevant organizations, explored ways to improve data collection and management practices.

During this seminar, delegates from respective national agencies and private partners shared their data on tuna unloading, which was classified by their fishing ground, fishing gear, and species (skipjack, yellowfin, and big-eye tuna).

Afterward, representatives from the participating agencies presented their existing data on annual tuna catches, which was validated and submitted to the WCPFC. This review determined whether the Philippines complies with the fishing quotas and whether the tuna stocks are healthy.

Officials from PFDA – Davao Fish Port Complex (PFDA-DFPC), PFDA – General Santos Fish Port Complex (PFDA-GSFPC), PFDA – Lucena Fish Port Complex (PFDA-LFPC), and PFDA – Navotas Fish Port Complex (PFDA-NFPC) joined the participants from the Philippine Statistics Authority (PSA), National Stock Assessment Program (NSAP), SOCSKSARGEN Federation of Fishing and Allied Fishing, and West Pacific East Asia (WPEA) Project in the two-day workshop.
