

YEAR-END MESSAGE FROM THE GENERAL MANAGER


Binabati ko ang lahat para sa isa na namang matagumpay at makabuluhang taon ng pagtulong sa ating mga mangingisdang Pilipino.

On Fish Unloading and Handling

Another year has passed and the PFDA Regional Fish Ports (RFP) made sure that they will end it on a high! During the fourth quarter of 2024, the PFDA RFPs delivered 126,903.94 metric tons (MT) of fish and other fishery products to all their consumers. This high volume of annual fish unloading is equivalent to an average daily unloading volume of 1,379.39

When it came to ice production, the PFDA RFPs produced 9,755.75 MT of ice and processed 412.16 MT of fishery and non-fishery products.

On Serving Port Clients

As we leave 2024 behind us, we are always thankful and grateful to all our clients and stakeholders who played a huge part in our agency's success. In the final agarter of the year, the PFDA RFPs served 9,585 clients and welcomed 18,391 vessels from October to December 2024.

PFDA PORT UTILIZATION RATE

On Port Facilities Utilization

Flagship rehabilitation in PFDA RFPs continue to go in full swing as the year changes. With our constant pursuit to serve more clients and stakeholders, the utilization rate of piers and quays reached 168%. This high utilization rate is slowly improving as improvement projects move closer to completion.

Meanwhile, utilization of market halls was at 87%, and building spaces, commercial & industrial areas sat at 84% utilization rate.

In addition, the utilization rate for ice making plants reached 74%, cold storage utilization reached 73%, and processing rates recorded 49% utilization rate.



PFDA REHABILITATION UPDATES

PFDA ends the year with two newly rehabilitated fish ports; continues to improve remaining six

The Philippine Fisheries Development Authority advances forward in port rehabilitation and improvement of all PFDA Regional Fish Ports (RFP) for the last quarter of 2024.

Completed in 2022, the PFDA - Lucena Fish Port Complex (PFDA-LFPC) is going steady with their quality service to the people with their new and improved facilities.

With a recently completed rehabilitation, the PFDA - Davao Fish Port Complex (PFDA-DFPC) can finally provide a more efficient service to its people and customers.

Subsequently, the rehabilitation on PFDA - Sual Fish Port (PFDA-SFP) is also recently completed and currently serving its stakeholders with rightly priced and quality fish supply.

The PFDA - Iloilo Fish Port Complex (PFDA-IFPC) is just footsteps away from completion with a rate of 95.47%.

Moreover, the PFDA - Camaligan Fish Port (PFDA-CFP) is more than halfway through its development process with a rate of 56.04%.


Additionally, the PFDA - Zamboanga Fish Port Complex (PFDA-ZFPC) is also striving to better serve its clients with a completion rate of 55.88%.

Meanwhile, the construction of the two phases of the PFDA - Navotas Fish Port Complex (PFDA-NFPC) is ongoing. Currently, the average rate for the Phase 1 and Phase 2 of the PFDA-NFPC is 75.70% and 82.83% respectively.

Lastly, the PFDA - General Santos Fish Port Complex (PFDA-GSFPC) is working tirelessly to serve their clients more efficiently with a rate of 23.52%.

PFDA harmonizes structural requirements, eyes food safety certification

Thirty-one personnel from the Philippine Fisheries **Development Authority - Technical Services** Department (PFDA-TSD) and PFDA Project Management Office (PFDA-PMO) engaged in an orientation on Food Safety Standard Structural Requirements of the Market Hall and Cold Storage Facilities on October 4, 2024, at the PFDA Central Office, Diliman, Quezon City.

The orientation is a part of the ongoing joint initiative of the PFDA – Operations Services Department (PFDA-OSD) and the TSD to harmonize all ongoing and future PFDA projects with the Food Safety and Environmental standards, policies, and laws.

The one-day workshop was geared towards reinforcing the agency's understanding of the structural prerequisites of the Market Halls and Cold Storages in compliance with Food Safety, with the end goal of obtaining certification from the regulatory agencies on Good Hygienic Practices (GHP) and Hazard Analysis Critical Control Points (HACCP) such as the Bureau of Fisheries and Aquatic Resources (BFAR) and the National Meat Inspection Services (NMIS).

Mr. Dennis E. Tiotangco, former Fisheries Inspection and Quarantine Division (FIQD) Chief under BFAR, was the resource speaker during the orientation.



PFDA boosts food safety campaign, finalizes sanitation protocols in RFPs

Philippine Fisheries Development Authority (PFDA), through its Operations Services Department -Quality Assurance Division (OSD-QAD), conducted a writeshop on the finalization of Sanitation Standard Operating Procedures (SSOP) for PFDA Regional Fish Ports (RFP), at the Agricultural Training Institute (ATI), Quezon City, on October 7 to 11, 2024.

The primary objective of the five-day writeshop is to finalize a comprehensive SSOP manual to ensure the consistent and effective implementation of sanitation protocols across all PFDA RFPs, particularly in their market halls and cold storage facilities.

Mr. Dennis E. Tiotangco, former Chief of the Fisheries Inspection Unit of the Fisheries Inspection and Quarantine Division at the Bureau of Fisheries and Aquatic Resources, was the resource speaker during the SSOP workshop.

This writeshop directly supports the achievement of the Agency's five-year plan to acquire Good Manufacturing Practices (GMP) and Hazard Analysis and Critical Control Points (HACCP) certification for PFDA facilities and processes.

Furthermore, this writeshop represents a crucial step towards aligning all port operations with international regulations and standards, such as the European Union's Codex Alimentarius (Food Code).

Moreover, the participants discussed the incentivization of the Check F.R.E.S.H. Program. This program aims to promote food safety and sanitation measures in PFDA RFPs by persuading fish port clients that achieving safer fish ports is possible through cooperation and positive reinforcement.

Eighteen (18) officials and personnel across all nine PFDA RFPs actively participated in the five-day activity.

PFDA personnel learn Creative and Effective Selling Techniques

Philippine Fisheries Development Authority (PFDA) engaged in a Seminar-Workshop on Creative and Effective Selling Techniques (CEST) at University of the Philippines – Institute for Small-Scale Industries (UP-ISSI), Diliman, Quezon City, on October 14 to 18, 2024.

The week-long seminar-workshop aims to apply the communication tools needed to effectively win customers, identify the innovative marketing techniques to ultimately improve overall sales performance, determine the different selling approaches in generating repeat and bigger sales orders through good understanding of after-sales service, apply practical insights in the art of marketing either as a career or simply gain a strong foothold on the dynamics of salesmanship, and prepare a marketing plan.

Mr. Gerard Joseph B. Alava, a professor at the Virata School of Business in UP Diliman, served as the

resource person of the workshop. Among the topics he discussed in the workshop are: the selling process, approach to effective selling, best practices in handling objections, best practice in closing the sale, and how to prepare a sales plan.

Strengthening the agency's commitment to its Corporate Social Responsibility (CSR), the activity was aimed to extend gratitude and support to the utility and security personnel who tirelessly contribute in maintaining the agency's daily operations and safety.

The CCPFDA distributed Christmas baskets to a total of 20 recipients: 10 utility personnel (5 males and 5 females) and 10 security personnel (10 males).



or most of us, 5 o'clock in the morning is just the time to wake up to face the day to come. But for some people, like Jeric Barbas, 24 years old, laborer, is already at the PFDA - Zamboanga Fish Port Complex (PFDA-ZFPC) waiting for the docking of the buti or bangka, small fishing boats that deliver freshly

His primary task involves unloading and transporting heavy loads of fish from the landing quay to the Market Hall, a tedious work that requires tremendous physical effort.

In Tausua:

"Bang niya buti o bangka magbuhat kami box ubos binuwanan kami daying in daying iya elle in bayad makami pabilliha kami para makasin."

(Bawat buti o bangka ay tagabuhat kami ng box at binibigyan kami ng isda. Yun ang bayad sa amin at binebenta namin para kami ay magkapera.)

Laborers like Jeric are not paid in monetary terms, but instead are compensated by receiving a portion of the day's catch as payment for a day's work as fish brokers also have yet to sell their fish.

This arrangement calls for laborers to sell the fish they collected in order to generate income or take the caught fish home for their families to eat, either of which depends on the volume of fish landed and market demand.

The economic conditions for laborers can be quite challenging. During certain periods, particularly around the full moon, the catch is significantly reduced, leading to fewer boats docking at the port.

Such incidents emphasize the often unpredictable nature of their livelihoods.

The scarcity of fish unloading further harbors competition among laborers, often resulting in chaotic and confrontational situations caused by limited number of fish boxes.

"In tahanang labor susa pasal mintu ka kami holat ma daying sin supplier ma fishing port."

(Ang buhay ng pagiging labor ay mahirap dahil umaasa lang kami sa isda ng supplier na dumadagsa sa fishing port.)

In response to these challenges, the PFDA- ZFPC has introduced a systematic intervention to address the disorder and inequity that arise during times of scarcity. This intervention involves the implementation of a structured allocation system such as queuing. This ensures a fair distribution of available work to all laborers.

By reducing disputes and fostering a more equitable environment, this initiative by the PFDA-ZFPC management has provided laborers with a degree of stability and reduced the competitive tensions previously experienced by the laborers like Jeric.

Despite these countermeasures, Jeric's financial security remains subject to external variables. including fluctuations in fish supply and market pricing. On days when the catch is abundant, oversupply drives prices down, further complicating the laborers' economic situation.


Nevertheless, Jeric continues to adapt to these challenges. His daily routine concludes in the evening. Then, he relies on the fish he received as payment to purchase his and his family's everyday needs.

The story of Jeric serves as a microcosm of the labor dynamics at the PFDA-ZFPC, reflecting the endurance of individuals to navigate and overcome everyday challenges.

Jeric's perseverance, as seen in his smile despite carrying heavy loads of fish even before the dawn breaks, reflects the spirit of resilience.

His story is a testament to PFDA-ZFPC's commitment to empowering individuals and driving economic progress for all stakeholders, fishermen, brokers, laborers, and beyond.

The five-day workshop aims to consolidate and align all the plans and budgets of PFDA Central Office support units and Regional Fish Port (RFP) operating units. Moreover, the objective of this conference is to ensure efficient and effective plans and budget allocation.

Six (6) Regional Fish Ports (RFP) of the Philippine Fisheries Development Authority (PFDA) secured the recertification of their International Organization for Standardization (ISO) 9001:2015 Quality Management System for Public Administration covering Market and Harbor Operations in the last quarter of 2024.

The PFDA ports, namely: PFDA - Navotas Fish Port Complex (PFDA-NFPC), PFDA - General Santos Fish Port Complex (PFDA-GSFPC), PFDA - Davao Fish Port Complex (PFDA-DFPC), PFDA - Zamboanga Fish Port Complex (PFDA-ZFPC), PFDA - Iloilo Fish Port Complex (PFDA-IFPC), and PFDA - Lucena Fish Port Complex (PFDA-LFPC) successfully complied with the requirements of their respective annual ISO surveillance audits.

For three years in a row, the PFDA-NFPC successfully passed the surveillance audit for its ISO 9001:2015 recertification on October 9.



The PFDA-DFPC also passed its third consecutive recertification on October 30 with zero non-conformities.

PFDA elevates gender-responsive infrastructure development through HGDG, PIMME workshop

Thirty (30) personnel from the Philippine Fisheries Development Authority - Central Office (PFDA-CO) participated on a Gender and Development (GAD) Training-Workshop on Harmonized Gender Development Guidelines (HGDG) and Project Implementation, Management, Monitoring, and Evaluation (PIMME) on November 4 to 8, 2024 at the PFDA Central Office Building, Diliman, Quezon City.

To open the training-workshop, Technical Services Department (TSD) Manager Engr. Danilo A. Axalan acknowledged the participation of mostly engineers, architects, and other key personnel for the workshop. He said that as project implementers, he recognizes the importance of attributing GAD-related undertakings in all construction and rehabilitation activities of all PFDA Regional Fish Ports and other developmental projects.

"I hope with this training-workshop, we can all have a deeper and wider understanding on how we can champion gender inclusivity in our future infrastructure projects," Engr. Axalan said.

The week-long activity aims to develop the HGDG as a tool to ensure gender equality and women empowerment in the agency's present and future programs and projects.

Additionally, the workshop provided a consistent framework for combining gender considerations. It also demonstrated how to use the HGDG for measuring project progress and integrating it into GAD Planning and Budgeting.

Moreover, tips and reminders in preparing and revising gender-responsive program proposals

using the results of HGDG Design Checklist as well as GAD Planning and Budgeting (GPB) were also discussed during the training.

During the five-day training-workshop, the participants actively engaged in various workshops including an assessment of PFDA Design Proposals, preparing a Gender-Responsive Program Proposal, finalization of the GPB, assessing programs and projects through HGDG PIMME Checklist, and preparing the accomplishment report of the PFDA flagship programs/projects.

"I hope all the future projects of PFDA can be genderresponsive," said by Ms. Psyche Mae A. Asencio, member of the PCW National GAD Resource Pool who served as the resource speaker for the five-day activity.



PFDA-GFPS Drives Institutional Transparency with Workshop on SDD and CODI Orientation

A. Macaranas II said that this training workshop is
the PFDA's steppingstone to progress its Gender
Mainstreaming Evaluation Framework (GMEF) and
Harmonized Gender and Development Guidelines
(HGDG) scores.

"Malaking factor ang SDD at Gender Statistics sa GAD activities, pati na rin sa overall activities ng PFDA dahil lahat tayo ay parte statistics... Mainam na ma-familiarize at maappreciate natin ang SDD at CODI, at isama ang mga ito sa ating mga programa,"

Mr. Macaranas said.

Ms. Josephine Gabriel-Banaag, a Philippine Commission on Women (PCW) National GAD Resource Pool (NGRP) Certified Member, was the resource speaker for the training workshop.

On the first day, Ms. Banaag highlighted the importance of Sex-Disaggregated Data (SDD) and Gender Statistics (as linked to Gender Analysis) in policy and program formations. Afterward, Ms. Banaag guided the participants in designing forms to collect SDD/Gender Statistics.

Subsequently, the participants gained a deeper understanding of various laws in the Philippines aimed at addressing gender-based harassment, including the Sexual Harassment Act of 1995 (R.A. 7877) and the Safe Spaces Act (R.A. 11313).

Lastly, Ms. Banaag emphasized the importance of a Committee on Decorum and Investigation (CODI) within an organization and discussed the application of gender sensitivity in handling sexual harassment reports.

A total of 39 participants, 27 female (69.23%) and 12 male (30.77%), from the PFDA Central Office and Regional Fish Ports (RFP) actively participated in the training workshop.
