"Brighter days ahead."


These clichés are overused not because they are empty—but because they have been useful and inspiring to so many people—and to me—so many times.

Q1 2025 IN NUMBERS

On Fish Unloading and Handling

A new year begins, and the PFDA Regional Fish Ports (RFP) are ready to welcome it with renewed energy and commitment to excellence. Kickstarting the first guarter of 2025, the PFDA RFPs unloaded 119.063.77 metric tons (MT) of fish and other fishery products, with an average daily unloading volume of 1,434.50 MT of fish. The PFDA ports had also started the year positively when it came to ice production and processed products, producing 9,523 MT of ice and processing 248.86 MT of fishery and nonfishery products

On Serving Port Clients

As we welcome the year 2025, the PFDA, together with all its RFPs nationwide, extends its heartfelt gratitude to all clients and stakeholders whose continued support and partnership push the agency towards success. During the first quarter of the new year, the PFDA RFPs catered to 9.986 clients and welcomed the arrival of 20.496 vessels.

This quarter, the utilization rate of piers and quays reached 238%. This high utilization rate will eventually improve as rehabilitation projects inch closer to completion.

The Philippine Fisheries Development Authority (PFDA) and its Regional Fish Ports (RFP), are actively manifesting new year clichés! With major port upgrades and improvements already underway, the PFDA is ensuring that every port is prepared to meet the demands of the future.


This is PFDA's year of progress. It is not just a cliché phrase; it is a reality in the making!

Following the completion of the PFDA – Lucena Fish Port Complex (PFDA-LFPC) in 2022 and the PFDA - Davao Fish Port Complex (PFDA-DFPC) in 2024, the PFDA - Sual Fish Port (PFDA-SFP) and the PFDA - Iloilo Fish Port Complex (PFDA-IFPC) are proud to announce that they will soon be ready to serve the public with more efficient and modernized infrastructures as rehabilitation in the respective ports reach 100% completion.

These new completed PFDA RFPs will soon be open to all, offering improved services that will benefit both the local communities, clients and stakeholders, and industry partners.









Not far behind, the construction on the two phases of the PFDA - Navotas Fish Port Complex (PFDA-NFPC) is making swift progress as we enter the new year. As of March 2025, the construction and improvement of the PFDA-NFPC Phase 1 is 88.07%, and for Phase 2 is 88.06%.



CFP) and the PFDA - Zamboanga Fish Port Complex (PFDA-ZFPC) reached halfway through their rehabilitation process with 60.55% completion rate and 58.75% completion rate, respectively. The future shines bright for Camarines Norte and Zamboanga del Sur, with revitalized ports on the horizon.





Finally, the construction and rehabilitation of the PFDA - General Fish Port Complex (PFDA-GSFPC) enters the year in full swing with an average of 30.64% completion rate.





PFDA conducts Board Meeting in 2025; showcases past year accomplishments

Philippine Fisheries Development Authority (PFDA), led by Acting General Manager Atty. Glen A. Pangapalan, held a PFDA Board Meeting for Fiscal Year (FY) 2025, at the PFDA - Central Office, Diliman, Quezon City on February 17, 2025.

PFDA Board of Directors Chairperson and Department of Agriculture (DA) Secretary Mr. Francisco "Kiko" P. Tiu Laurel Jr. and the members and representatives of the PFDA Board of Directors were present during the meeting. They discussed the future of the fishing industry with the help of the PFDA and its intervention of flagship projects throughout the country.

At the start of the meeting, Secretary Laurel noted the need to maximize the value of the catch of our fisherfolk through the construction of fishery postharvest facilities in strategic locations.

"Kailangan nating mabawasan ang spoilage at palawakin ang naaabot ng ating mga mangingisda

upang matulungan natin silang mapataas ang kanilang kita. (We have to decrease food spoilage and increase the range of our fisherfolk so we can help them increase their income)," the Secretary said.

During the meeting, Corporate Planning and MIS Department Manager Ms. Gina J. Reyes and Finance Services Department Manager Mr. Jose A. Ruiz, Jr. proudly presented the physical accomplishments and financial performance of the PFDA for FY 2024, respectively.

In addition, Technical Services Department Manager Engr. Danilo A. Axalan introduced the PFDA Fisheries Infrastructure Development Programs and Projects of the PFDA for FY 2025 to 2026.

Afterwards, OIC-Assistant General Manager Atty. Edward M. Campos presented the PFDA Infrastructure Projects for Award of Contract.

DBM visits PFDA-NFPC, observes ongoing flagship projects

They observed the ongoing construction of the new PFDA Central Office building, the Modern Market Halls, and the additional area for fishery post-harvest facilities.

In addition, the DBM team also visited Market Hall 1 and the new FG Cold Storage Corporation.







After the tour, the other ongoing flagship rehabilitation projects in the PFDA RFPs were presented via drone livestreaming by Technical Services Department Manager Engr. Danilo A. Axalan. All these projects are funded under the multi-year national government subsidy to PFDA.

Three-in-a-row! PFDA receives FOI Compliance Certificate for 2023

For three consecutive years, the Philippine Fisheries Development Authority (PFDA) received a Freedom of Information (FOI) Certificate of Compliance for 2023 from the FOI - Program Management Office (FOI-PMO) under the Presidential Communications Office (PCO), on February 12, 2025.

This certificate reflects PFDA's ongoing commitment to transparency by providing clients, stakeholders, industry partners, and the public with convenient access to necessary information on the agency's programs, projects, and essential data. Established under Executive Order No. 2, series of 2016, the FOI program serves as the government's demand to its agencies for transparency and full public disclosure of information, thus enabling Filipino citizens to request details about government transactions and operations, as long as such requests do not compromise privacy or national security.

The PFDA has appointed FOI Receiving Officers and Decision Makers who assist with information requests from external agencies, groups, and organizations.

Philippine Fisheries Development Authority (PFDA), through its Operations Services Department – Quality Assurance Division (OSD-QAD), in coordination with the PFDA - Iloilo Fish Port Complex (PFDA-IFPC) Food Safety and Environmental Unit (FSEMU), conducted a forum on Food Safety Practices to PFDA-IFPC's fish brokers on March 20, 2025.

The forum was aimed to present the standards on compliances to food safety and environmental practices, enhance the participants' practical knowledge and skills in implementing best practices in food handling, storage, and waste management, and foster a culture of continuous improvement and proactive compliance within the port community.

The discussion also focused on the principles of the Food Safety Act 2013, the do's and don'ts in handling fish and fishery products, and proper housing, keeping, and disposal of waste.

Ms. Kimberly S. Orande and Mr. Michael Chester V. Francisco from the OSD-QAD served as the lecturers on the forum.

PFDA boosts digital literacy through IT training

Philippine Fisheries Development Authority Central Office (PFDA-CO), through its Information Technology Division (ITD), conducted three Information Technology (IT)-related trainings aimed to equip the participants with the skills and knowledge to effectively set up, operate, and troubleshoot technology used to work efficiently.

The first training was the Virtual Meeting Platform Training where the participants were taught to effectively set up, operate, and troubleshoot the use of a 360-degree camera for virtual meetings.



The training aims to enhance users' ability to use the camera's 360-degree capabilities for immersive, engaging virtual experiences, ensuring smooth integration with virtual meeting platforms, and improving overall meeting efficiency and collaboration. The training took place on February 17, 2025 at the PFDA Central Office, Diliman, Quezon City.

The training was conducted by Geoplan Philippines,

The second training was the Advanced Microsoft Excel and Powerpoint Training held on February 24-28, 2025 via teleconference. The week-long training equipped the participants with advanced skills in Microsoft Excel and Microsoft PowerPoint, enabling them to effectively utilize complex formulas, pivot tables, macros, advanced animations, master slides, and design techniques.

The training aims to enhance participants' ability to apply these tools in real-world scenarios, improving their productivity, data analysis, and presentation design, and ultimately boosting their overall efficiency in professional settings. Personnel from Richmark Computer Sales and Services served as the resource speaker in this training.



The last IT-related training was the Information Security Management System (ISMS) Awareness Training that took place on March 3-7, 2025 at the Ground Floor, PCA Function Hall, Diliman, Quezon City. The training was to ensure that employees understand the principles of information security, their roles and responsibilities in maintaining it, and how to comply with ISMS policies and procedures.

The training aims to equip participants with the knowledge to identify and manage security risks, protect sensitive data, and respond effectively to security incidents, ultimately strengthening the organization's overall information security posture. Mr. Ireneus Lazlo Legeza II served as the resource speaker in this week-long training.



PFDA leads Drug-Free Workplace Awareness Program in partnership with PDEA

Philippine Fisheries Development Authority (PFDA) conducted a Drug-Free Workplace Awareness Program on March 21, 2025, at the Philippine Coconut Authority (PCA) Auditorium, with experts from the Philippine Drug Enforcement Agency - National Capital Region (PDEA-NCR) serving as resource speakers.

The program aimed to educate PFDA personnel on drug classification, its ill effects on individuals and workplaces, and the consequences of drug use. Additionally, it provided guidance on formulating a Drug-Free Workplace Policy to promote a safe and productive work environment.

The topics discussed were drug identification and its ill effects, Drug-free Workplace Policy, and the salient provisions of Republic Act (RA) 9165 or the Comprehensive Dangerous Drugs Act of 2002.

Mr. Arvin Gaye Targa, Chief of Public Information and Media Relations Section and Mr. Paulo Victor A. Daculla, Supervising Administrative Officer and Chief of Preventive Education and Community Involvement (PECI) Section of PDEA-NCR served as the resource persons for the event.



Additionally, the PFDA - Iloilo Fish Port Complex (PFDA-IFPC) also participated in the Philippine Drug Enforcement Agency Regional Office VI's (PDEA RO-VI) Drug Abuse Prevention Education and Drug-Free Workplace Program on March 6, 2025 at the PFDA-IFPC Admin Building.

The lecture was aimed to equip PFDA-IFPC personnel with knowledge about drugs and the effects of drugs, and to ensure that the participants are well-informed and capable of creating a drug abuse policy to make the fish port a drug-free workplace.

The topics discussed include, different forms of drug abuse, penalties under Republic Act 9165 - Comprehensive Dangerous Drugs Act of 2002, roles of individuals in drug prevention, effects of drugs, and the components of drug-free workplace program.

Public Information Officer Ms. Ma. Graziella Tanaleon, Legal Officer Atty. Bomrad Soc Abonado, and Agent Mr. Paulo Nicole delos Santos of PDEA served as the resource speakers for the event.

PFDA strengthens equipment maintenance through TPMM writeshop

Philippine Fisheries Development Authority (PFDA) participated in the Total Productive Maintenance Manual (TPMM) writeshop conducted by the University of the Philippines Institute for Small-Scale Industries (UP-ISSI). The training sessions were held on January 23-24, February 7, 14, 21, and 28, and March 13-14, 2025, through online and in-person sessions at E. Virata Hall, University of the Philippines Diliman, Quezon City.

Aimed to enhance maintenance strategies for PFDA's Regional Fish Ports (RFPs), the writeshop equipped participants with knowledge on developing a TPM framework, proactive maintenance practices, key



performance metrics, and standardized equipment maintenance procedures. These efforts seek to optimize equipment efficiency, reduce downtime, and improve operational performance across fishery post-harvest facilities.

At the end of the writeshop, the participants were able to develop a TPMM framework, create detailed productive maintenance procedures for various electromechanical equipment and fishery post-harvest facilities, and prepare maintenance schedules, activities, and monitoring documents. Participants will refine the framework based on evaluator feedback before full implementation.

PFDA participates in disaster preparedness, emergency response training

Philippine Fisheries Development Authority (PFDA) participated in the Basic First Aid, Search and Rescue Training, and Fire Drill conducted by the Bureau of Fire Protection - Quezon City Fire District (BFP-QCFD) on March 18 to 19, 2025 at the Philippine Coconut Authority (PCA) Auditorium and Agro-Hub Complex.

The training aimed to equip the PFDA personnel with the skills to provide immediate assistance and care in emergencies, stabilize situations, and potentially save lives until professional help arrives.

The topics discussed in the two-day training include Composition of Emergency Response Team, Basic Bandaging, Fire Safety protocols, Basic Life Support, and Search and Rescue. In line with the Fire Prevention Month, the participants also assigned an ad hoc Incident Command Group among themselves for the fire drill and search and rescue to simulate real-life fire incidents.

BFP-QCFD Senior Fire Officer 1 (SFO1) Jayson S. Santiago, SFO2 Rendell Jay V. Buquing, Fire Officer 3 (FO3) Yousef-Amin G. Tillah, FO1 Royland A. Enriquez, FO3 Jan Marde A. Del Rosario, SFO1 Richard Andrew A. Roces, SFO2 Virgilio E. Remonde Jr., and FO2 James D. Luminis served as the resource speakers for the training.

Meanwhile, the PFDA - Zamboanga Fish Port Complex (PFDA-ZFPC) personnel also strengthened their emergency preparedness by participating in a Fire and Safety Seminar and Drill led by the Philippine Marine Corps' Marine Battalion Landing Team (PMC-MBLT) on February 20, 2025.

The seminar featured Senior Fire Officer 1 (SFO1) Edgar Guevarra from the Bureau of Fire Protection (BFP) Sangali Station as the resource speaker. Mr. Guevarra provided insights into fire prevention techniques, safety measures, and emergency response protocols, emphasizing the importance of proactive fire safety efforts.

Following the seminar, participants performed actual firefighting techniques during a hands-on drill.

Rough-Waters by Robert Gregory Q. Elardo

It was around midnight when I sat across my laptop, repeatedly reading the transcript of our featured client's interview. I don't know where to start and I've been thinking about a good angle on her interview since Monday; It's Thursday now, and the deadline is loomina.

Then the gods of writing seemed to come down from the heavens of letters, finally blessed me with some spiritual sight; I finally saw it! My eureka moment, the 'flood rope' to my I-am-a-fraud-writer moment, the dots that I can finally connect.

I live in a flood-prone area. Whenever there's a flood, our barangay tanods put a 'flood rope' in the middle of the street that reaches through the most flooded area for evacuees.

Our case study is Liz Vidal Abelligos, a business owner. Although she started her own business, almost 11 years ago, she's been active in the Philippine Fisheries Development Authority — Camaligan Fish Port (PFDA-CFP) for longer.

It was 1993 when the young Liz started as an employee of a fish-processing company with a Taiwanese investor. But, when the business closed because of some issues, it affected not only Liz's livelihood but all the employees who worked there.

Even so, Liz endured, she paddled through the waters and grasped the opportunity to start her own business – Kim Marine Products.

Kim Marine Products is a fish processing company that exports seafood such as cuttlefish, octopus, giant squid, scallops, freshwater shrimp, and yellow eel to different countries like China, Taiwan, and Vietnam. Her company is mostly women.

"Dito po sa amin, ang karamihan sa amin ay babae, halos babae ang nag-aasikaso ng (fish) farm, very strong po sila. Parang mga Amazona dito ang mga tao ko. Magagaling po sila." says Liz, praising her employees.

Of course, a successful business is not without problems; most businesses at the time were affected by COVID-19, and Kim Marine Products is no exception. Thankfully, with the assistance of the PFDA-CFP, production still continued and her business stood well despite the challenges brought by the pandemic.

The typhoons Roly and Ulysses, which were only a month apart, also affected her business, compelling her to shell out huge expenses to recover and fix things.

With many years of experience in her pocket, it's not surprising that she handles these kinds of problems well. But we're humans after all, capable of feelings of loss.

"Pero okay naman so far." She says with a tone of both relief and woe.

Her employees also played a crucial role in keeping her business. With their dedication, her business kept afloat. "Sa mga empleyado ko, very supportive sila.
Tumutulong sila sa akin no matter what.
Kahit anong mangyari nandyan pa rin sila.
Nagpapasalamat ako kasi kung hindi dahil sa kanila, wala itong Kim Marine Products." she says proudly.

Throughout the years, the PFDA grows and continues to build fishery infrastructures and post-harvest facilities that can support business owners such as Liz. She continues to work hard to expand her business and to make one of her wishes for her products to reach European countries. With her employees and the PFDA-CFP management by her side, and her unwavering dedication, it's just a matter of time.

"Kailangan natin maging masikap, masinop.
Sipagan lang at maging honest tayo sa kapwa
natin. Kung hindi natin kaya ang mga problema,
kailangan ma-inform natin agad. Kasi minsan, may
mga problema tayo na ma-e-encounter na early,
as much as possible, masolusyunan na agad." she
says.

With Liz's story, we saw her 'flood rope', we saw resilience; we saw that any problem can be solved either with assistance or alone, navigating through waters.

Through the flood of frustrations, burnout, and existential crisis, with Liz's story, I saw my 'flood rope'; that we will always encounter challenges in life, and it's important that we deal with them one by one. May Liz's story inspire you and get you through rough waters.


PFDA-LFPC receives Mother-Baby Friendly Workplace Certification

In accordance with Bureau of Fisheries and Aquatic Resources (BFAR) Administrative Circular 255, also known as the 'Establishment of Closed Season for the Conservation of Sardines within Sibuguey Bay, Basilan Strait, and East Sulu Sea,' the closed fishing season promotes sustainable practices and ensures the long-term viability of the sardine industry, which is vital for the region's economy, livelihood, and food security.



During the ceremony, BFAR Regional Fisheries Office (RFO) IX Assistant Director Isidro M. Velayo Jr. acknowledged PFDA-ZFPC Port Manager Mr. Ignacio M. Yao's continued support and dedication to sustainable practices in sardine fishing.










PFDA kicks off 2025 National Women's Month Celebration

14 male (66.67%) and seven female (33.33%) PFDA-CO personnel participated in the GSO.











Philippine Fisheries Development Authority (PFDA), through the PFDA - Gender and Development Focal Point System (GFPS), organized a National Women's Month 2025 Film Showing in partnership with the Philippine Coconut Authority (PCA) and EdukSine Studios Corporation on March 24 to 28, 2025 at the PCA Auditorium, Diliman, Quezon City.

All personnel from the PFDA - Central Office and PFDA Regional Fish Ports (RFP) were invited to the simultaneous block screening of the movie "Retirada" (The Retiree). Retirada explores life's meaning and purpose in the face of old age and death. In a society where being young and active is given more merit, growing old can lead to a sense of alienation and even depression as one contemplates one's own mortality.

For the PFDA Regional Fish Ports (RFP), the PFDA - Davao Fish Port Complex (PFDA-DFPC) was the first port to hold a block screening of the film on March 24, 2025. A total of 40 personnel, with 10 female (25%) and 30 male (75%), watched the film.

Meanwhile, three female (37.5%) and five male (62.5%) participants attended the film showing in PFDA - Sual Fish Port on March 25, 2025. On March 26, 2025, the PFDA - Navotas Fish Port Complex held a block screening of the film which was viewed by 25 female (61%) and 16 male (39%) participants.

At the same time, the PFDA - Iloilo Fish Port Complex also held their film showing which was streamed by 20 female (50%) and 20 male (50%) participants.


